Build My Future Rules & Regulations UPSTATE MO

CONTRACT OBLIGATIONS: No exhibitor will be permitted to set up their booth 13. REMOVAL OF EXHIBIT: All exhibits must remain set up until 2pm on 1. until all fees are paid.

EXHIBITOR ELIGIBILITY RIGHT OF REFUSAL AND/OR CANCELLATION: Build My 2 Future Upstate Missouri/AGC of Missouri Education Foundation reserves the right to determine the eligibility of any exhibitor. In the event of non-acceptance, the fee shall be returned to the applicant. Once the applicant has been accepted, the full cost of the exhibit space is due and payable in the manner described in the fee schedule. Exhibits and the conduct of exhibitors are subject to Build My Future Upstate Missouri/AGC of Missouri Education Foundation's approval, which reserves the right to refuse the application of any company not meeting the required standards, as well as the right to curtail exhibits including the Policies, Rules and Regulations of Macon County Fairgrounds

displays, literature, advertising, novelties, souvenirs, and personal conduct of exhibitors. Officers, employees, and agents involved in the management of the Build My Future Upstate Missouri/AGC of Missouri

and enforce all rules and regulations governing Exhibitors. All matters and questions including, but not limited to, music, video, and software. Exhibitor shall not specifically addressed in the rules shall be subject to final determination by Build My Future Upstate Missouri/AGC of Missouri Education Foundation. The rules may be amended at any time by Build My Future

Upstate Missouri/AGC of Missouri Education Foundation upon notice to Exhibitors. In addition to any other recourse referenced in these rules and regulations, Build My Future Upstate Missouri/AGC of Missouri Education Foundation may have recourse for the violation of any of these rules in any manner it deems appropriate, including expulsion of an exhibitor from the show and suspension from future shows.

3. EXHIBIT SPACE: A. For each 10x10 space, Build My Future Uptate Missouri/ AGC of Missouri Education Foundation shall provide one 6 foot table and two chairs. BOOTH SIGNAGE WILL BE THE RESPONSIBILITY OF THE VENDOR.

4. MOVE IN: Macon County Fairgrounds does not provide any equipment to help with move in or tear down. Please come prepared with any equipment you need to help move your product.

5. fails to comply in any respect with the terms of these rules and regulations, Build My Upstate Missouri/AGC of Missouri Education Foundation related to these Future Upstate Missouri/AGC of Missouri Education Foundation shall have the right to rent such space to any other applicant without releasing the original exhibitor from paying the sum agreed to in the application and contract for exhibitexhibitor, and indirect or consequential damages may not be sought. space.

FIRE SAFETY: No combustible oils or gases may be used as part any indoor 6. exhibit, nor will any open flames be permitted without prior written approval of the agencies if they are the prevailing party. Fire Marshall. All electrical equipment used in conjunction with the display's installation, operation, and dismantling must be in good operating condition and able to pass the inspection of the local Fire Marshall. Storage of excess materials in hallways is prohibited.

CARE OF EXHIBIT SPACE: Each exhibitor must keep their own space cleaned 7 and their exhibit maintained in good order while the show is open to the public.

8. located inside the building. Exhibitors will need to bring extension cords.

EVENTUALITIES: In case the exhibit hall should be destroyed by fire or the 9. elements, or by another cause, or in case other circumstances shall make it impossible for Build My Future Upstate Missouri/AGC of Missouri Education Foundation to permit the contracted space to be occupied by exhibitor, the application and contract for exhibit space shall terminate and the exhibitor shall waive any claim for damages or compensation.

10. LIABILITY: Neither Build My Future Upstate Missouri/AGC of Missouri Education Foundation, the employees thereof, their agents or representatives; nor Macon County Fairgrounds, the employees thereof, their agents or representatives nor anystructural integrity in its exhibit design and the proper construction and safety member of Build My Future Upstate Missouri/AGC of Missouri

Education Foundation shall be responsible for any injury, loss or damage that may occur to the exhibitor, or to the exhibitor's employees or property from any cause whatsoever prior, during or subsequent to the period covered by the application and contract for exhibit space; and the exhibitor on signing the contract expressly Whatever these rules do not cover, Build My Future Upstate Missouri/AGC releases the foregoing named Association, Corporations, individuals, their agents and employees from any and all claims for such loss, damage, or injury.

11. SET-UP OF EXHIBITS: Hours for set-up of exhibits are Tuesday 12 noon to 5pm and Wednesday 6:30am to 8:30am.

12. SHOW TIMES: The show will be open to the students 9am - 2pm on Wednesday.

UNOCCUPIED SPACE: If the exhibitor fails to occupy space contracted for, or 18. Exhibitor may obtain such coverage at its own expense. Exhibitor remains responsible for all ELECTRIC NEEDS: Access to 110 service will be supplied for each exhibit spaceproperty brought into the Show and shall bear the sole risk of loss for that property. Exhibitor shall indemnify and hold harmless Build My Future Upstate Missouri/AGC of Missouri Education Foundation, and its directors, agents and employees from any damages caused by theft or other perils normally covered by extended coverage, liability, theft, or fire policies, as well as for all claims, losses, liability, or damages for injury, death, or property damage that may arise from activities of the exhibitor, its employees, agents, invitees, and licensees.

22. PENALTIES: The penalty for violation of any rule CAN result in immediate booth closure and suspension of exhibitor's right to be in the next year's show
